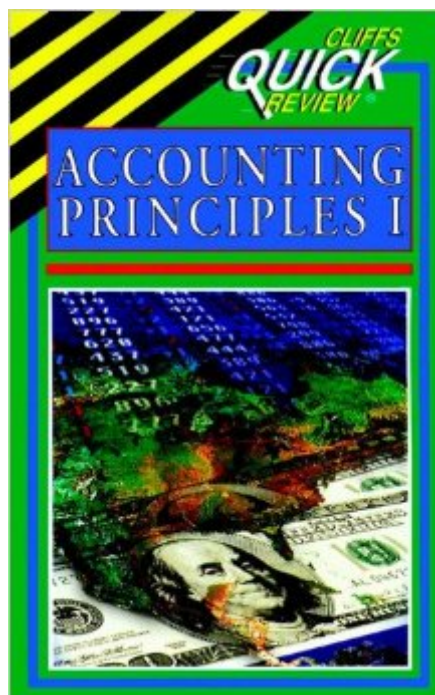

Everything is presented clearly and concisely, and it coincided with each chapter in my text book rather well.
